



Nove mere sa primenom na teritoriji cele Republike Srbije	New measures with application on the entire territory of the Republic of Serbia
<p>Nakon jučerašnje sednice Kriznog štaba, donete su nove mere koje stupaju na snagu u petak, 17. jula 2020. godine i koje će važiti <u>za celu teritoriju Republike Srbije, bez obzira na to da li je u određenoj opštini ili gradu proglašena vanredna situacija.</u></p>	<p>After yesterday's session of the Crisis Headquarters, new measures were adopted which will take effect as of Friday, 17 July 2020 and <u>apply to the territory of the Republic of Serbia, regardless of whether a certain municipality or city declared a state of emergency.</u></p>

<p>Mere podrazumevaju:</p>	<p>The measures include:</p>
<ol style="list-style-type: none"><li data-bbox="250 1028 795 1304">1. zabranu okupljanja na javnim mestima u zatvorenom i otvorenom prostoru za više od 10 ljudi. Za vreme boravka na javnim mestima, između okupljenih mora postojati distanca od najmanje 1,5 m, odnosno na svaka 4 m² može biti prisutno jedno lice;<li data-bbox="250 1343 795 1545">2. proširenje mere obavezognog nošenja zaštitnih maski u zatvorenom prostoru koja je već na snazi u Beogradu, na teritoriju cele Republike Srbije, bez izuzetka;<li data-bbox="250 1583 795 1888">3. obavezno nošenje zaštitnih maski i na otvorenom, i to <u>na mestima u kojima nije moguće držati fizičko rastojanje od 1,5 m</u>, poput redova ispred prodavnica, apoteka, autobuskih i voznih stajališta i slično. Na svim ostalim javnim mestima na otvorenom prostoru <i>preporučuje se</i> nošenje zaštitnih maski.	<ol style="list-style-type: none"><li data-bbox="854 1028 1395 1304">1. a ban on gathering in public places in indoor and outdoor areas for more than 10 people. During stay in public places, a distance of at least 1.5 m must be maintained between gathered persons, i.e. one person may be present on every 4 sq. m;<li data-bbox="854 1343 1395 1545">2. extension of the measure of mandatory wearing of protective masks in indoor areas, which is already in force in Belgrade, on the territory of the entire Republic of Serbia, without exception;<li data-bbox="854 1583 1395 1859">3. mandatory wearing of protective masks in outdoor areas, in places where it is not possible to maintain a physical distance of <u>1.5 m</u>, such as queues in front of shops, pharmacies, bus and train stops, etc. It is <i>recommended</i> to wear protective masks in all other outdoor public places.
