<p>Nakon današnje održane sednice Kriznog štaba, donete su nove mере koje će se do dalnjeg primenjivati na teritoriji grada Beograda.</p>	<p>After today's session of the Crisis Headquarters, new measures were adopted which will be applied on the territory of the city of Belgrade until further notice.</p>
<p>Napominjemo da još uvek nije objavljena formalna odluka, već se ovo obaveštenje zasniva na saopštenju predsednice Vlade Republike Srbije.</p>	<p>Please note that this notice is based on the announcement of the Serbian prime minister and that the formal decision on this matter is still pending.</p>
<p>U pitanju su sledeće mere:</p>	<p>The measures include:</p>
<ol style="list-style-type: none"><li>1. zabranjuje se organizovano javno okupljanje više od <b>10 osoba</b>, kako u zatvorenom tako i na otvorenom prostoru;</li><li>2. ograničava se broj ljudi u zatvorenim prostorima. Svaki ugostiteljski objekat, prodavnica, apoteka i drugi objekti zatvorenog tipa će morati jasno da istaknu koliko je osoba dozvoljeno da bude u objektu i to tako da se za <b>svako lice mora obezbediti najmanje četiri kvadratna metra</b>;</li><li>3. ograničava se radno vreme zatvorenih objekata tako da se u istim ne obavlja delatnost od <b>21:00 čas do 6:00 časova ujutru</b>, a ova mera stupa na snagu od sutra. Ovo ograničenje važi ne samo za ugostiteljske objekte, već i za prodavnice, tržne centre i sve ostale zatvorene objekte. Za otvorene prostore i bašte ostaje zabrana rada od <b>23:00 časova do 06:00 časova ujutru</b>.</li></ol>	<ol style="list-style-type: none"><li>1. a complete ban on public gatherings of more than <b>10 people</b> in indoor and outdoor areas;</li><li>2. the number of persons in indoor areas is limited. Each catering facility, store, pharmacy and other closed type facilities will be obliged to have a clear indication of the number of persons allowed on premises, so that <b>at least 4 sq.m. must be provided for each person</b>;</li><li>3. limited working hours of closed type facilities in such a way that performing their business activity is prohibited from <b>9 p.m. to 6 a.m.</b>, which shall take effect as of tomorrow. This limitation applies not only to catering facilities, but also stores, shopping centres and all other closed type facilities. In terms of outdoor spaces and gardens, prohibition of operating will remain from <b>11 p.m. to 6 a.m.</b></li></ol>
