

Nove mere za suzbijanje COVID-19	New measures for suppressing COVID-19
<p>Poštovani klijenti,</p> <p>Vlada Republike Srbije donela je nove mere za suzbijanje COVID-19 koje stupaju na snagu u utorak, 24. novembra.</p> <p>Nove mere su:</p> <ul style="list-style-type: none">- skraćenje radnog vremena do 18:00h restoranima, kafićima, barovima, klubovima, kladionicama i tržnim centrima;- obavezno nošenje maske u zatvorenom, kao i na otvorenom prostoru u onim situacijama u kojima se ne mogu izbeći međuljudski kontakti;- zabrana svih javnih okupljanja s prisustvom više od 5 osoba u zatvorenom i na otvorenom prostoru (od ove mere izuzete su radne organizacije, školske ustanove, prodavnice, tržni centri i slični objekti za koje važi propisano ograničenje od minimum 4 m² po osobi);- omogućavanje rada od kuće svim zaposlenima u slučajevima u kojima radni proces to dopušta;- stroga kontrola obaveze nošenja zaštitne maske u vozilima javnog prevoza, uz ograničenje maksimalnog broja putnika u vozilu na polovinu deklarisanog kapaciteta vozila;- stroga kontrola sprovođenja kućne izolacije, kućnog karantina i samoizolacije, kao i svih ostalih mera koje su na snazi.	<p>Dear clients,</p> <p>the Government of the Republic of Serbia has adopted new measures for suppressing COVID-19 which enter into force on Tuesday, 24 November.</p> <p>The new measures include:</p> <ul style="list-style-type: none">- shortening of working hours until 6 p.m. for restaurants, cafés, bars, clubs, casinos and shopping centers;- mandatory wearing of face masks indoors, as well as outdoors in situations in which interpersonal contact cannot be avoided;- ban on all public gatherings with more than 5 persons, both indoors and outdoors (this excludes workplaces, educational institutions, stores, shopping centers and similar objects in which the limitation of 4 square meters per person is stipulated);- enabling work from home to all employees in cases where the work process allows;- strict control of wearing of face masks in public transport vehicles, with a reduction of the maximum number of passengers in the vehicle to one half of the declared capacity of the vehicle;- strict control of the implementation of home isolation, home quarantine and self-
